	This will require an understanding of existing regulatory funding mechanisms, experience applying for external funding streams such as UK government schemes and proactive horizon scanning, taking ownership of identifying new funding opportunities.
	The role will require working closely with the Innovation & Funding Manager to ensure the balance between organisational needs and funding availability, and with internal colleagues across Net Zero, Legal and Procurement to develop project scope in line with funding guidelines. Candidates should have a proven funding application portfolio ideally with experience of managing timely and successful applications for multi-million-pound projects in an energy related background.
